

DIRECTIONS TO THE TRIAL SITE

FROM THE SOUTH

Whidbey Island is accessible from I-5/I-405 via Rte 525 or Rte 526 to MUKILTEO-CLINTON ferry dock. Follow SR 525 north from the ferry for 25 miles. (****THE ROAD DESIGNATION CHANGES*** It will become SR 20 north of the turnoff to the Keystone-Pt. Townsend ferry after SR 525 milepost 30) Just past SR 20 milepost 18 - Morris Rd. will be on your right after reaching the Naval outlying field. Turn right onto Morris Rd. then take the first left onto Parker Rd. The Pacific Rim Institute is on the right. (formerly known as AuSable Institute.)

FROM THE NORTH

Whidbey Island is accessible from I-5 via SR 20 and Deception Pass bridge. Follow SR 20 through Oak Harbor and head south. Pass through the Coupeville streetlight and Morris Rd. will be on your left immediately as you come to the Naval Outlying field on your right (milepost 19.) Turn left onto Morris Rd then take the first left onto Parker Rd. The Pacific Rim Institute is on the right.

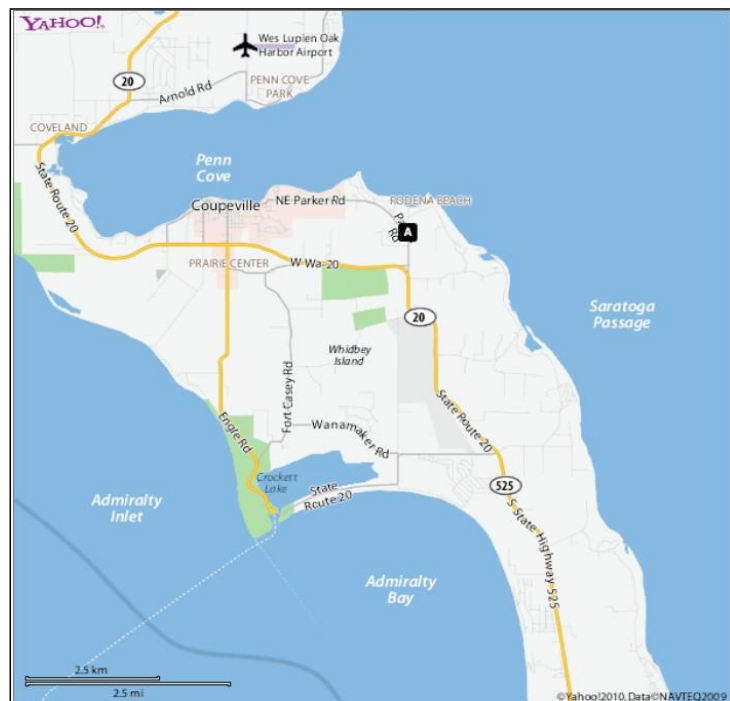
FROM THE WEST

Whidbey Island is accessible from SR 101 and the Olympic Peninsula via the Pt. Townsend-Coupeville (Keystone) ferry dock. Reservations recommended <https://business.wsdot.wa.gov/ferries/reservations/> Follow SR 20 to right from the ferry for 2 miles. Turn left on Wanamaker Rd. Bear right on Keystone Hill Rd. Turn Right on Patmore Rd. Turn Left on State Route 20. Turn right onto Morris Rd. then take the first left onto Parker Rd. The Pacific Rim Institute is the next road on the right.

THE DACHSHUND CLUB OF AMERICA INC. further offers to the winner of **Open All Age Dog Stake** and/or **Open All Age Bitch Stake**, and **Field Champion Combined Stake** its Brass Sunburst Medallion when entries in that stake are 12 or more.

NOTICE TO EXHIBITORS

Dogs must be at least 6 months old. AKC registered Dachshunds that are intact, spayed or neutered or have a Limited Registration may participate. Dachshunds with ILP or PAL Numbers are NOT eligible for this competition.

ONLY COMPLETE ENTRY FORMS INCLUDING REGISTRATION NUMBER will be accepted.

TRACKING COLLARS will be allowed. The collar surface against dog's neck shall be flat (no protrusions). While dachshunds are under judgement, handheld devices must be turned off. Handheld devices may be turned on only after the dachshund has been eliminated from competition by the judges or judgement has ceased.

Bitches in season are eligible for entry in OAAB, but are not eligible for entry into any combined sex stake.

Unless being judged, all dogs are to be held on leash under control while on the trial running grounds and campus. **No unattended dogs may be left in exercise pens.**

Returned checks do not constitute a valid entry fee.

The Test Secretary shall add a \$25.00 collection fee to the amount of each returned check.

Bring water, shade and shelter for you and your dogs. This trial will be run rain or shine.

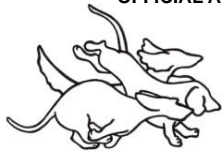
